What does it cost?

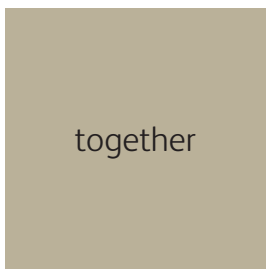
The cost to enrol as a Member of NSARE Limited is:

- SME Organisations** £250
(as defined under the Companies Act)

What obligations does it confer on your organisation?

NSARE Limited is a not for profit organisation limited by guarantee. This means that:

- Profits made by NSARE Limited will be reinvested in the company and will not be distributed to Members
- In the event of the financial failure of NSARE Limited Members will be liable to the amount of their guarantee, which will not exceed £1 per Member
